01 The document. "The ECAR Model" (version 2), later referred as the ECAR 2 document, written by Mr Matti Mattila, CIA, CISA (author) will be delivered by "Fact-Finding Service". More information about the document is available on the internet at <http://www.f-fs.net/> and about "Fact-Finding Service" at <http://www.ytj.fi/english/>

02 Price. Unless otherwise agreed, price of the ECAR 2 document in an electronic form is determined in the US dollars (USD) according to the table 1. The price shall be paid either directly either (1) onto the bank account in Finland IBAN: FI73 1279 5000 4829 36; BIC: NDEAFIHH or (2) onto PayPal account m2la@nic.fi.

03 Owner of the ECAR 2 document copy. The owner of the ECAR 2 document's copy (owner) will be the payer or the payer organization, and information about it will appear, partly or fully, in the footer of the pages of the document. The owner may use the copy of the ECAR 2 document in a computerized form, where it is delivered, and, in addition, he/she is may keep no more than one paper copy of the ECAR 2 document, printed by himself/herself. If the paper copy in broken, torn or spoiled in other way, and he/she can print a new copy in stead of it provided that he/she destroys the spoiled copy so that it cannot be used or assembled anymore.

04 Request for the delivery. The buyer shall ask for a delivery of the ECAR 2 document. The following details shall be included in the request: details of the payment (by whom or by which organization, date), the owner of the copy of the ECAR 2 document, and the email address, where information about its delivery will be sent. The buyer shall send the request to the following email address: f-fs@welho.com, or, if this address is not in use, the email address told on the web site <http://www.f-fs.net/>. The recommended heading of the email message is "Ecar 2 document delivery". The buyer can attach a PKI digital signature (e.g. free trial of Verisign) to the message by signing it, for encryption of the messages, if he/she wants to.

05 The delivery of the ECAR 2 document. If the buyer's email message is PKI digitally signed, the information for obtaining the copy/copies of the ECAR 2 document will be delivered in an encrypted email message. In other cases, the buyer will be sent an email message or more of them, containing necessary information for the delivery of the ECAR 2 document during a period of four weeks. The ECAR 2 document will not be delivered until the buyer gives the details necessary (1) for furnishing the copy with the owner's name and (2) for delivery of the copy, i.e the information mentioned above [in 03 and 04].

06 Owner's responsibilities. The owner shall keep the copy of the ECAR 2 document protected such a way that it cannot be copied against the terms mentioned above and against the copyright legislation in force in his/her own country. It is forbidden to make a copy of the ECAR 2 document available on the intranet, internet or any other such forum or place, unless agreed with Fact-Finding Service. The owner of the copy of the ECAR 2 document may lend the paper copy mentioned above [in 03] to another person, provided that he/she himself/herself does not use the document in any form during the lending period.
